



COOPERATION AGREEMENT BETWEEN UNIVERSITY OF BORÂS AND

FUNDAÇÃO UNIVERSIDADE DO ESTADO DE SANTA CATARINA - UDESC

With the objective of strengthening their mutual cooperation as well as striving for the promotion of reciprocal exchanges, **UNIVERSITY OF BORÂS**, **FACULTY OF TEXTILES**, **ENGINEERING AND BUSINESS** represented by its Dean Tobias Richards, located at Allégatan 1, 501 90 Borås, Sweden and **FUNDAÇÃO UNIVERSIDADE DO ESTADO DE SANTA CATARINA - UDESC**, represented by its rector Professor Dilmar Baretta, having its address at Avenida Madre Benvenuta, 2007, Itacorubi, Florianópolis, Santa Catarina, Brazil, have concluded the following Agreement:

Article 1: Fields of Cooperation

Cooperation between the two universities will be undertaken from the perspective of promoting academic and cultural ties. That cooperation will include educational and research activities in all fields and disciplines offered at the two institutions.

Article 2: Forms of Cooperation

- 1. Both universities agree that their cooperation will include, but not be limited to the following goals:
 - The promotion of exchange of faculty members and researchers from both institutions;
 - ii. Facilitation of the acceptance of faculty members and researchers from both institutions who are preparing for their doctoral thesis;
 - iii. Promotion of collaborative research and collaborative publication of research results by faculty members and researchers from both institutions;
 - iv. Promotion of the exchange of students from both institutions;
 - v. Promotion of the exchange of reference data, publications, and academic information and literature.
 - vi. Facilitation of the mutual exchange of administrative and secretarial personnel attached to the academic departments and colleges, research laboratories and centers, libraries, and various administrative bodies of each institution.

 Except for those provisions set forth explicitly in this document, any conditions related to implementing the activities referred to in this Agreement will be negotiated by both institutions. The concerned parties agreed to this in a written document before commencing the activities.

Article 3: Exchange of Faculty Members and Researchers

- Both universities will endeavor to facilitate visits by faculty members and researchers from the other. Visiting faculty members and researchers will also comply with the administrative procedures required and the host university's regulations.
- 2. Both universities may provide economic support for visiting faculty members or researchers from the other institution but are not required to do so.
- Both universities will assist visiting faculty members and researchers from the other university in searching for accommodations but are not required to provide such accommodations.
- 4. Both universities will accord visiting faculty members and researchers from the other institution the use of research space, libraries, and other facilities and opportunities to audit lectures free of charge. To this extent, possible other common courtesies are generally granted to visiting scholars.

Article 4: Student Exchanges

- The agreement encourages, but is not limited to, student exchanges within the subject areas Business Administration, Textile Management, Textile Technology and Engineering at both undergraduate and graduate level.
- 2. The number of exchange students from each institution will annually include, but not be limited to, ten (10) students per academic year. Each institution will discuss the possibility of increasing the number and subject areas of exchange studies within the resources and circumstances of each institution on a yearly basis.
- Each institution shall be responsible for selecting students participating in the exchange, subject to final approval by the host institution. The sending institution will provide information on selected students according to the nomination process by the deadline prescribed by the receiving institution. The participating students from both institutions shall pay the enrolment fee to their home institution and then study at the other institution without further charges for tuition fees.
- 4. Each institution shall support visiting students in searching for accommodation. However, the cost of said local accommodation shall be the responsibility of and borne by the visiting students. Each participating student or sending institution shall be solely responsible for travel arrangements and costs. The additional charges, such as passports, visas, telephone services, books, and any other kind of personal taxes, will also be the responsibility of each student.

5. Each University can help its students by providing specific scholarships, and each institution will require participating students to maintain their health insurance to provide coverage while participating in student exchange. All students must provide evidence of such insurance to the host institution.

All students, including exchange students, registered at University of Borås are covered by a personal injury insurance (the general student insurance). The insurance applies in Sweden during school hours and during travel to and from the location where school hours are spent. Insurance conditions can be found at www.kammarkollegiet.se.

Exchange students in Sweden from outside the EU/EEA are, in addition to the general student insurance, covered by the Swedish state's insurance for foreign students in Sweden, Student IN. Students' admission letters serve as proof that they are exchange students and covered by the insurance Student IN.

Exchange students from University of Borås studying abroad are covered by the Swedish state's insurance during education abroad, Student UT. Insurance conditions can be found at www.kammarkollegiet.se. It applies twenty-four hours a day in the country of study.

6. The student will also comply with administrative procedures and the host university's regulations.

Article 5: Agreement Administrators

Ultimate responsibility for this Agreement lies with the President of each institution, but administrative responsibility for its administration will be delegated to the following officers at each institution.

- (i) For University of Borås: Gustav Kibe, International Coordinator
- (ii) For Santa Catarina State University: Dean of Interinstitutional and International Affairs.

Article 6: Validity of the Agreement

- This Agreement will come into force on the date that the governing bodies of both universities give their formal approval and will remain in effect for 5 (five) years, after which it may be renewed.
- 2. Either party may terminate this Agreement by officially notifying the other party of its intent to do so in writing by registered post six (6) months in advance.
- 3. The provisions of this Agreement may be amended at any time by mutual consent in writing of both universities.
